**1. ORDER QUANTITY AND FREQUENCY**

The ESIC Medical college and Hospital, Bihta, BIHAR proposes to order ERT Injection Cerezyme (Imiglucerase) 400IU/VIAL, 3 vials every 15 days for a period of 6 months. Quoted rate will be fixed for at least one year however, if rate decrease by the firm, it should be informed in time and order will be placed accordingly. ## 2. FATE OF UNUSED VIALS

In case any vials are left unused due to any reason, M/s Sanofi Healthcare India Pvt. Ltd. shall take back the unused vials and refund the cost of the unused vials to the ESIC account No. 2.

## 3. SELF LIFE OF DRUGS FOR ACCEPTANCE.

Injection Cerezyme shall have a minimum 50% of the shelf life remaining from the date of manufacture for use.

## 4. PAYMENT TERMS

## 5. PAN/TAN DETAILS

M/s Sanofi Healthcare India Pvt. Ltd. shall provide their PAN and TAN details to the ESIC Medical College & Hospital, Bihta, Patna-801103.

## 6. SUPPLY THROUGH OTHER AGENCIES

In case M/s Sanofi Healthcare India Pvt. Ltd. supplies the ERT Injection Cerezyme (Imiglucerase) through any other authorised agent, the rate shall be the same as approved, and a tripartite agreement shall be required with binding to other terms and conditions as applicable.

## 7. PENALTY FOR DELAY SUPPLY

The supply will be made within 15 days of the issue of the Purchase order/Requisition from Direct Demanding Officer (DDO's) though e-mail. However, a penalty of 0.5 percent (0.5%) of the value of the order calculated at the contract rate per week or a part of a week will be levied.

## 8. PACKING AND SUPPLIES

The supply should be with strict cold chain maintenance (If required) in proper box/packet. The cost of the transportation will be borne by M/s Sanofi Healthcare India Pvt. Ltd. The purchaser will not pay separately for transit insurance and the contractor will be responsible for delivery of items covered by the supply order in good condition at the specified destination and for this purpose freight, insurance, Octroi etc, if any, will have to be borne by the supplier.

## 9. AGREEMENT COMMUNICATION

This Agreement shall be communicated to the Headquarters of the ESIC with an intimation that the drug procurement order is going to be placed.

## 10. PROCUREMENT DETAILS

The ESIC Medical College & Hospital, Bihta, Patna-801103, proposes to procure ERT Injection Cerezyme (Imiglucerase) 400IU/VIAL, 3 vials every 15 days for a period of 6 months. The total expenditure for six months of ERT shall be Rs. 22,95,432/- (Rupees Twenty-Two Lakh Ninety-Five Thousand Four Hundred Thirty-Two only) plus GST as applicable.

## 11. PURCHASE ON DEMAND BASIS

Demand of items may be increased or decreased as per actual requirement of this hospital. The medicine shall be purchased on demand basis (stagger manner) as per clinician recommendation.

## 12. DAMAGE DURING TRANSPORTATION

Any damage during the transportation of the drug shall be the full responsibility of M/s Sanofi Healthcare India Pvt. Ltd., and ESIC Medical College & Hospital, Bihta, will not liable for any payment if item is found to be damaged or not in usable condition.

## 13. VALIDITY

The Agreement is Valid for 06 months from the date of Signing. However, it would be extended on mutual consent on same terms and conditions in case the approval of treatment is extended beyond 06 months. In that case no additional agreement would be signed but the same would be extended on timely manner, as required with exchange of communication on this matter.
